On 18 May 2007, Orion Equities Limited (OEQ), a controlled entity of QUE, disposed of its wholly owned subsidiary, Hume Mining NL, to Alara Uranium Limited (AUQ) in consideration of the issue of 6,250,000 AUQ shares. Hume Mining NL has interests in uranium tenements located in the Northern Territory and Western Australia.

AUQ commenced trading on ASX on 24 May 2007. The above AUQ shares are subject to escrow for 24 months from the date of official quotation of AUQ's shares on ASX.
